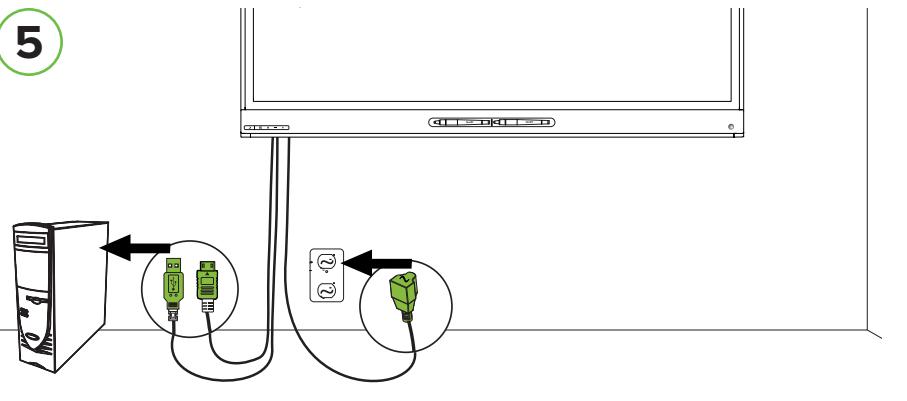

Federal Communication Commission interference statement
